From the President: A review of the Legislative Forum

The LWV of East Alabama held its Legislative Forum for Lee County Delegates on Monday, January 27th, from 7-9PM in the Auburn City Council Chambers. League member Barbara Patton served as a wonderful and gracious moderator who juggled questions from the League as well as the audience. We were so pleased to have five of our nine delegates present including Speaker Mike Hubbard, Senator Billy Beasley, Senator Gerald Dial, Representative Mark Tuggle and Representative Pebblin Warren. Those who were absent were Sen. Lesley Vance, Rep. George Bandy, Rep. Dwayne Bridges and most notably Sen. Tom Whatley of Auburn.

As I noted in last month's *Voter*, I was hesitant to proceed with the forum since I wasn't sure it was worth the time and effort. I was reminded by Ruth Wright and Carol Daron that the Legislative Forum is one of those outreach events meant for the public as much as it is for our members and that we really should proceed with it. I am pleased that we did! We had about 60 citizens attend the event and I am sure that number would have been much higher if the impending winter weather had not been an issue. We had a nice notice in the O-A News as well as an editorial espousing the importance of the forum and a follow-up article after the event. While this last article focused mainly on the education and healthcare questions, we asked a total of 15 questions that went well beyond these two topics. Payday loans, Constitutional Reform, the spay/neuter bill, minimum wage options, Open Meetings laws, Department of Conservation Funds, midwifery and offenses at Tutwiler prison were also mentioned. About half of the questions were penned by the League and the other half came from the audience.

I asked each of the members who attended to send me their impressions of the forum to see what worked and what we need to improve. I was happy to hear from so many of you. Most thought it was well organized and very professional but the lack of follow up questioning was a drawback. Since audience questions were submitted to a review panel for relevance and content, it was not possible immediately to challenge a delegate on his/her answer with a follow-up question. Short of changing the format of the forum to allow for direct questions from the audience, I am not sure how to obviate this problem. At this point, I prefer to have the moderator addressing the delegates in order to control the tenor and pace of the event.

Celebrating 94 Years of Making Democracy Work

Ninety-four years ago on February 14, 1920, pioneering suffragist Carrie Chapman Catt founded the League of Women Voters to secure the right to vote for women. Within just a few months, Congress would grant American women the vote after decades of advocacy.

But that did not complete the League's work - and our work is still not done today. Barriers to the ballot box might look different today, but threats to our democracy remain. Last year, the U.S. Supreme Court issued a decision which gutted a key component of the monumental Voting Rights Act

(VRA) of 1965, but last month members of Congress introduced legislation to update the VRA through common sense solutions.

Tell Congress you support the Voting Rights Amendment Act of 2014.

This bipartisan legislation was carefully crafted to protect the rights of all voters from discrimination and repair the damage to the VRA inflicted by the Supreme Court's decision. The updated legislation seeks to better protect all voters against discrimination and ensure Americans are guaranteed their right to vote.

The modernized VRA will ensure that equal access to the ballot box is about fairness and equality - something that Carrie Chapman Catt knew when she founded the League of Women Voters.



Nearly 100 years after the League was founded, we continue to hold fast to the belief that our nation is at its strongest when the voices of all voters are heard. "There will never be a true democracy until every responsible...adult in it, without regard to race, sex, color or creed has his or her own...voice in government," said Chapman Catt. The Voting Rights Amendment Act of 2014 is a critical step to ensure just that.

The League refuses to remain silent as voters across the country face grave barriers to the vote. Urge your elected officials to support this important legislation and encourage them to act swiftly to move toward final passage.

We also talked about numerous books we had read. Laura and Neali have been immersed in tomes about local civil rights while I have been fascinated by American history, particularly during the time of the American Revolution. Neali just finished *Black In Selma: The Uncommon Life of J. L. Chestnut, Jr.* by J. L. Chestnut and Julia Cass and Laura read <u>Outside the Magic Circle: The Autobiography of Virginia Foster Durr</u>. Laura also found time to read about the Montgomery Bus Boycott and the critical involvement of <u>Jo Ann Robinson</u> in the planning and execution of the boycott. Other topics included the gutting of the Voting Rights Act by the Supreme Court (and the effect that has had on Alabama) and even the advent of three-dimensional printing and the consequences, both good and bad, that this technology can bring. Clara mentioned that she is tutoring students at the Boys and Girls Club at the Boykin Community Center and commented on the issues that some kids are having with basic concepts like multiplication tables. She has a wonderful approach to teaching these kids as she asks a few key questions in order to gauge what they know. I am happy to say that I could answer at least one of her math questions. However, I was at a loss with her question about derivatives in calculus (she also tutors Auburn students). Will this stuff be on the test???

Anyway, we started talking about early education and Clara mentioned a book that she thought was very important to the education system in Alabama. She even sent a copy to Rep. Have you heard of "Bama Covered"?



We had a few Auburn University students at our Legislative Forum on January 27th and they mentioned the grassroots group Bama Covered. This nonpartisan, non-profit organization was founded in December of 2013 to enlist the help of

1000 college students to scour the state to talk to people about their healthcare options under the Affordable Care Act (ACA). According to their website (http://www.bamacovered.org/), nearly 650,000 Alabamians were uninsured in 2012 and many people are unaware of the details of the healthcare law and their options. Professor Wayne Flynt wrote an article for al.com entitled "The Sad State of the State's Health Care" and he mentioned Bama Covered while connecting the dots between health, education and jobs.
